## BASELINE YEAR & CURRENT REPORTING YEAR

Due to 2023 being the first year we have measured our CO<sub>2</sub>e emissions, the report for the Baseline Year and Current Reporting year contains the same figures. Due to this, the explanations below apply to both sets of data:

### SCOPE 1

Scope 1 is reported as 0.00 tCO<sub>2</sub>e in the 2023 due to **Vision ERP Limited** having no boilers, on-site manufacturing, a fleet or f-gases to report emissions on.

### SCOPE 2

Within Scope 2, we have measured the emissions resulting from employees working exclusively from home. As all of **Vision ERP Limited** employees are currently working remotely full-time, we have calculated the emissions generated from the consumption of purchased gas and electricity used for heating, lighting, and computer usage in home offices.

### SCOPE 3

#### BUSINESS TRAVEL

The Business Travel Subset in Scope 3 is reported as 0.00 tCO<sub>2</sub>e in 2023 due to **Vision ERP Limited** not travelling by Air, Rail, Bus, travel in rental cars or travel.

#### EMPLOYEE COMMUTING

The Employee Commuting Subset in Scope 3 is reported as 0.00 tCO<sub>2</sub>e in the 2023 for **Vision ERP Limited**. This is because, with employees operate fully remote, there is no recorded data available for employee commuting.

#### UPSTREAM AND DOWNSTREAM TRANSPORTATION

- All client meetings are held over teams, preventing emissions from business travel.
- All Staff have been provided with energy efficient laptops, reducing emissions generated from remote working.
